### 1. RULES

The regatta will be governed by:

- 1.1 The rules as defined in the « Racing Rules of Sailing »(RRS) 20013/2016
- 1.2 Prescriptions of national authority applied to foreign competitors are stated in "Prescription" if necessary.
- 1.3 Tour de France Micro 2016 regulations.
- 1.4 In case of language conflict, the French text will prevail.

### 2. ADVERTISING

According to ISAF Regulation 20 (Advertising code) as modified by FF Voile advertising regulation, boats may be required to display advertising chosen and supplied by the organizing authority.

### 3. ELIGIBILITY AND ENTRY

- 3.1. The regatta, Grade 4, is open to all boats of Micro Class
- 3.2. Eligible boats shall enter by completing the attached form and sending it, together with the required fee, to **A.C.A.L.- BP 30130 -67004 STRASBOURG CEDEX** by **2016/4/12**
- 3.3 Competitors living in France(each crew members) shall present when registering:
  - Their FFVoile valid license with the medical stamp, or a valid medical certificate (1 year) together with the parental consent.
  - if needed, the FFVoile advertising agreement
  - the measurement certificate
- 3.4 Foreign competitors (each crew members) who do not hold a FF Voile license shall justify of their membership to a National Authority member of ISAF and shall be insured with a valid third-party liability with a minimum cover of 1 500 000 €.  
the measurement certificate  
a valid medical certificate (1 year) together with the parental consent.

### 3.5 ENTRY FEES

Entry fees are **30 € per boat**

#### 4. SCHEDULE

4.1. Welcome on April 22<sup>th</sup> 2pm to 8pm and April 23<sup>th</sup> from 9am.

5 **MEASUREMENT CONTROL:** Equipment and measurement controls may be conducted before, during or after the races. Reminder: The lake is an open lake, corresponding regulation applies.

#### 7 COURSES

7.1 Courses to be sailed may be as follows: **Triangle - Trapezoid - Windward/Leeward**

#### 8 SCORING

**2** races are required to be completed to constitute a series.

8.1 General ranking on real time for all Micro and a ranking will be extracted from the general ranking for each division defined by Micro Class.

9 **PRIZES:** Cups, Trophies and prizes will be distributed for the ranking of each division and general ranking

#### 10. RADIO COMMUNICATION

Except in an emergency, a boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile telephones.

#### 11. DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. Decision to race or to continue racing is their own responsibility. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

12 The trainers wishing to use a motorboat are invited to declare it to the organizer by specifying the type and the registration of the boat.

13. **Photography consent :** Competitors, boat owners, coaches and organizers consent to the Organization all rights to use photos or videotapes of persons or boats taken before, during or after the regatta and to publish them in any media and publication relative to the activities of the Organization.

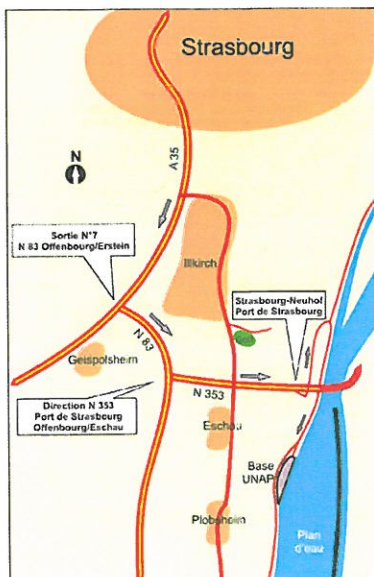
